## Regulatory Compliance

**Importers and Manufacturers of candles and/or scented candles and/or reed diffusers in EU and non-EU countries must comply with a wide range of regulations, safety standards, chemical restrictions, and labelling and testing requirements. ### Background

Candles and reed diffusers have become significant market products, and it's crucial to stay informed about the ever-evolving regulatory landscape surrounding them. Candles are subject to various regulations and safety standards. Developing strong hazard communication strategies is key to delivering these products quickly and efficiently to the market. Knowing specific requirements before marketing candles and reed diffusers avoids product recalls, incidents/injuries, and possible penalties.

### The Challenge

You need a clear understanding of both regulatory requirements and scientific principles to execute a clear regulatory strategy before placing candles and reed diffusers on the market.

In Europe, the General Product Safety Regulation [Reg (EU) 2023/988] is a framework legislation requiring that all products marketed in the EU are safe to use and analogous regulations apply in other countries. Hazard communication requirements differ around the world. Moreover, safety requirements beyond hazard communication need to be considered as well.

In the EU, compliance requirements applicable to candles and reed diffusers include the Classification, Labelling and Packaging (CLP) Regulation; the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) regulation; EN standards for candles (e.g., EN 15494, EN 15426, ASTM F-2417, etc.); the General Product Safety Regulation, among others.

  - Burning behaviour
  - Stability
  - Soot/smoke
  - Burn time
  - Wick behaviour
  - Flame heights
- **Material tests:** Lead and heavy metal content is tested in dyes, lacquers, surface coatings, and embedded materials used in candle and reed diffuser products—as well as in the wick and the candle wax itself—to

prevent harm to personal health and the environment.
